#### **RESOLUTION NO. 98**

Series of 2020

A RESOLUTION REQUESTING THE HONORABLE WENDEL E. AVISADO, SECRETARY, DEPARTMENT OF BUDGET AND MANAGEMENT (DBM), TO RELEASE TO THE MUNICIPALITY OF NARVACAN, ILOCOS SUR ITS ALLOCATION FROM THE COLLECTIONS OF TOBACCO EXCISE TAX PURSUANT TO REPUBLIC ACT NO. 7171 AND REPUBLIC ACT NO. 8240, AS AMENDED BY REPUBLIC ACT NO. 10351

**WHEREAS**, Republic Act No. 7171 or "An Act To Promote The Development Of The Farmers In The Virginia Tobacco Producing Provinces" aims to advance the self-reliance of the tobacco farmers through: cooperative, livelihood, agro-industrial and infrastructure projects;

**WHEREAS,** Republic Act No. 8240 provides the excise tax structure for cigarettes and liquor. It was amended by Republic Act No. 10351 or An Act Restructuring The Excise Tax On Alcohol And Tobacco Products which is primarily a health measure with revenue implications, but more fundamentally, a good governance measure that simplified the current excise tax system on alcohol and tobacco products;

**WHEREAS,** the Local Government Unit of Narvacan, Ilocos Sur, is a qualified beneficiary of RA No. 7171 and RA No. 8240 and has previously endorsed through Resolution No. 76, Series of 2020, to the DBM the programs and projects to be implemented out of the subject shares of the Municipality from the collections of tobacco excise tax pursuant to RA No. 7171 and RA No. 8240 as amended by RA No. 10351;

WHEREAS, LGU-Narvacan, Ilocos Sur has allotted Php178,751,111.00 and Php162,588,600.00 for its priorities under RA No. 7171 and RA No. 8240 respectively. Under RA No. 7171, the programs include the construction/ rehabilitation of farm-to-market roads, municipal roads, barangay roads; construction of Narvacan Farmer Government Center/Complex (Phase I); and construction/rehabilitation of Agricultural Post-Harvesting Facilities. Under RA No. 8240, the projects comprise of the

Narvacan Farmers Public Market/Commercial Complex (Phase I); procurement/acquisition of agricultural farming inputs/fertilizers; construction/rehabilitation of school buildings/health facilities/social service facilities; procurement/acquisition of various farm equipment; Narvacan farmer livelihood/financial support programs; construction/rehabilitation of farm-to-market roads, bridges, and other farm-to-market infrastructure projects; and construction/rehabilitation of flood control/drainage systems;

**WHEREAS**, the realization of the intended priority programs and projects is vital to the day-to-day working condition of the tobacco farmers in the Municipality;

**WHEREAS**, utilization and disbursement of the fund shall be in accordance with existing budgeting, accounting and auditing rules and regulations;

**NOW THEREFORE**, on motion duly seconded, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to request the HONORABLE WENDEL E. AVISADO, Secretary, Department of Budget and Management, to release to the Municipality of Narvacan, Ilocos Sur its allocation from the collections of tobacco excise tax pursuant to Republic Act No. 7171 and Republic Act No. 8240, as amended by Republic Act No. 10351;

**RESOLVED FURTHER,** that upon urgent certification of the Municipal Mayor and on motion unanimously approved suspending the rule on the 3-day reading of Resolutions, this Resolution shall take effect immediately upon approval;

**RESOLVED FINALLY,** that copies of this Resolution be forwarded to the HONORABLE WENDEL E. AVISADO, Secretary, Department of Budget and Management and to all persons and offices concerned for their information and appropriate actions.
