**RESOLUTION AFFIRMING THE REVOCATION OF APPOINTMENT OF MRS. MARY FE DE PERALTA AS CHILD DEVELOPMENT WORKER OF BARANGAY ESTANCIA, NARVACAN, ILOCOS SUR**

**WHEREAS**, the Sangguniang Bayan of Narvacan received Resolution No. 02, Series of 2020 of Barangay Estancia entitled "Resolution Revoking the Appointment of MRS. MARY FE DE PERALTA as Child Development Worker of Barangay Estancia, Narvacan, Ilocos Sur effective March 26, 2020";

**WHEREAS**, the revocation of appointment of MRS. MARY FE DE PERALTA was due to misconduct, loss of trust and confidence for breaking Municipal Ordinance No. 20, Series of 2020 "Ordinance Penalizing the False, Misleading or Untruthful Declaration of Any Patient in Times of Public Health Emergency or Pandemic";

**WHEREAS**, pursuant to Sec. 57 of the Local Government Code, the Sangguniang Bayan is given the power to review Barangay Ordinance and Issuances to determine if they are consistent with law and Municipal Ordinances;

**WHEREAS**, MRS. MARY FE DE PERALTA's violation of the Ordinance is a sufficient ground for disciplinary action of termination;

**WHEREAS**, Child Development Workers are supposed to serve as model of effective service enriching the parents' knowledge to take care of their children;

**WHEREAS**, this Resolution ceases MRS. MARY FE DE PERALTA from reporting at the Municipal Social Welfare and Development Office and from receiving her monthly honorarium from this Local Government Unit;

**NOW THEREFORE**, on motion duly seconded, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to affirm the revocation of appointment of MARY FE DE PERALTA as Child Development Worker of Barangay Estancia, Narvacan, Ilocos Sur;

**RESOLVED FURTHER**, that upon urgent certification of the Municipal Mayor and on motion unanimously approved suspending the rule on the 3-day reading of Resolutions, this Resolution shall take effect immediately upon approval;

**RESOLVED FINALLY**, that copies of this Resolution be forwarded to all persons and offices concerned for their information and guidance.
