RESOLUTION EARNESTLY REQUESTING THE HONORABLE MARK A. VILLAR, SECRETARY, DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH), TO PROVIDE FINANCIAL ASSISTANCE IN THE AMOUNT OF ONE HUNDRED FIFTY FOUR MILLION PESOS (PHP 154,000,000.00) FOR PRIORITY INFRASTRUCTURE PROJECTS OF THIS MUNICIPALITY

WHEREAS, the Department of Public Works and Highways (DPWH) is the executive department of the Philippine government solely vested with the mandate to be the state's engineering and construction arm;

WHEREAS, the DPWH is responsible for the planning, design, construction and maintenance of infrastructure, especially highways, flood control and water resources development system, and other public works in accordance with national development objectives;

WHEREAS, the Municipal Administration has placed on top of its development agenda the construction of various bridges that are truly responsive to the needs of the people and in pursuit of the National Development Objectives of the current administration;
