RESOLUTION EARNESTLY REQUESTING THE HONORABLE WILLIAM D. DAR, SECRETARY, DEPARTMENT OF AGRICULTURE (DA), TO PROVIDE FINANCIAL ASSISTANCE IN THE AMOUNT OF NINETY SIX MILLION FIVE HUNDRED THOUSAND PESOS (PHP 96,500,000.00) FOR AGRICULTURAL INFRASTRUCTURE PROJECTS OF THIS MUNICIPALITY

WHEREAS, the Department of Agriculture (DA) is the principal agency of the Philippine government responsible for the promotion of agricultural development;

WHEREAS, in partnership with Local Government Units (LGUs), the DA provides the support services necessary to make agriculture and agri-based enterprises profitable and to help spread the benefits of development to the poor, particularly those in rural areas;

WHEREAS, the Municipal Administration has placed on top of its development agenda the construction/concreting/improvement of various farm-to-market roads and construction of fish hatchery to increase agriculture productivity and make farmers and fishermen prosperous;

WHEREAS, in pursuing the right avenues for development, the Municipal Administration included in these priority agricultural infrastructure the following projects with their estimated costs:
