RESOLUTION AUTHORIZING THE HONORABLE LUIS "CHAVIT" C. SINGSON, MUNICIPAL MAYOR, TO EXECUTE A DEED OF USUFRUCT FOR THE USE OF THE LOWER PORTION OF THE BALIKBAYAN HALL IN FAVOR OF THE SUPREME COURT OF THE PHILIPPINES

WHEREAS, Republic Act 7160 otherwise known as the Local Government Code of 1991 provides that provinces, cities and municipalities shall endeavour to establish a government center where offices, agencies or branches of the national government, local government units, or government-owned or controlled corporation may, as far as practicable, be located;

WHEREAS, the same law authorizes a municipality to address the need of offices for other agencies of the government, because in the end, the services of such offices redound to the benefit of the public and the entire constituencies as a whole;

WHEREAS, the Supreme Court of the Philippines, in its aim to achieve speedy, adequate, quality administration of justice, as well as effective and efficient public service, particularly to the people of Narvacan, is requesting for space for its administration and dispensation of justice;

WHEREAS, recognizing the need for space and decent office for the Supreme Court of the Philippines due to its expanded operation and services to the people, the municipality is willing to convey by way of USUFRUCT the lower portion of the Balikbayan Hall located at the southeast corner of the Vegetable Section of the Public Market, in favour of the Supreme Court of the Philippines as the site of Narvacan Family Court;

NOW THEREFORE, on motion duly seconded, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to authorize the HONORABLE LUIS "CHAVIT" C. SINGSON, Municipal Mayor, to execute a Deed of Usufruct for the use of the lower portion of the Balikbayan Hall in favour of the Supreme Court of the Philippines;
