A RESOLUTION AMENDING RESOLUTION NO. 76, SERIES OF 2020 SPECIFICALLY ITEM NO. 2 OF THE LIST OF PROGRAMS AND PROJECTS UNDER RA 7171

WHEREAS, the Sangguniang Bayan of Narvacan, Ilocos Sur, during its 19th Regular Session held on May 26, 2020, passed and approved Resolution No. 76, Series of 2020;

WHEREAS, said Resolution endorses the program and project to be implemented out of the subject shares of the Municipality of Narvacan, Ilocos Sur from the collections of tobacco excise tax pursuant to Republic Act No. 7171 under Department of Budget and Management, Local Budget Memorandum No. 79, dated June 14, 2019;
