**RESOLUTION ADOPTING THE 2020-2022 PEACE AND ORDER AND PUBLIC SAFETY PLAN (POPSP) AS ENDORSED BY THE MUNICIPAL PEACE AND ORDER COUNCIL (MPOC)**

**WHEREAS**, presented for consideration of the Sangguniang Bayan of Narvacan, Ilocos Sur is Resolution No. 2020-2 of the Municipal Peace and Order Council (MPOC) entitled "Resolution Endorsing the 2020-2022 Peace and Order and Public Safety Plan (POPSP) for Adoption of the Sangguniang Bayan of the Municipality of Narvacan, Ilocos Sur";

**WHEREAS**, the POPSP was formulated in compliance with DILG Memorandum Circular No. 2015-128 for three (3) years effectivity upon adoption of this Sanggunian to be incorporated in the Municipality's Comprehensive Development Plan;

**WHEREAS**, perusal of the submitted plan reveals that the MPOC is aimed to enhance the capabilities of the law enforcers by implementing programs and activities that will develop their skills, promote innovative solutions by using modern technologies and encourage people's participation in building a safe and drug-free Narvacan;

**NOW THEREFORE**, on motion duly seconded, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to adopt the 2020-2022 Peace and Order and Public Safety Plan (POPSP) as endorsed by the Municipal Peace and Order Council (MPOC);

**RESOLVED FURTHER** that upon urgent certification of the Municipal Mayor and motion unanimously approved suspending the rules on the 3-day readings of Resolutions, this Resolution shall be adopted immediately upon approval;

**RESOLUTION ENDORSING THE 2020-2022 PEACE AND ORDER AND PUBLIC SAFETY PLAN (POPSP) FOR ADOPTION OF THE SANGGUNIANG BAYAN OF THE MUNICIPALITY OF NARVACAN, ILOCOS SUR**

**WHEREAS**, Section 5 of the 1987 Philippine Constitution emphasized maintenance of peace and order as one of the essentials for the enjoyment by all the people of the blessings of democracy;

**WHEREAS**, the general welfare clause of Republic Act 7160 otherwise known as the Local Government Code of 1991 mandated that every local government units shall exercise the powers expressly granted to them for the promotion of general welfare- among them are the maintenance of peace and order and preserve the comfort and convenience of their inhabitants;
