#### **RESOLUTION NO. 85**

A RESOLUTION APPROVING THE ACQUISITION OF IDENTIFIED **PROJECTS** OF THE MUNICIPALITY NARVACAN, ILOCOS SUR TO BE FUNDED BY THE LOCAL GOVERNMENT **SUPPORT FUND-OTHER FINANCIAL** ASSISTANCE TO LOCAL GOVERNMENT UNITS (LGSF-FA to **DEPARTMENT** LGUs) UNDER THE **BUDGET** MANAGEMENT (DBM)

**WHEREAS,** the Department of Budget and Management (DBM) has allocated Php 4.88 billion for the provision of financial assistance to local government units (LGUs) to support their priority programs;

**WHEREAS,** Budget Secretary WENDEL E. AVISADO issued Local Budget Circular 122 dated January 31, 2020, which laid out the guidelines for the release and utilization of the LGSF-FA to LGUs Fund under the 2020 General Appropriations Act;

**WHEREAS**, the Municipal Development Council of Narvacan, Ilocos Sur has identified various projects such as the procurement of: ambulance and related accessories, disaster response vehicle and related accessories, and backhoe loader and related accessories that will contribute to the economic development of the municipality;

**WHEREAS**, the proposed projects were adopted by the Sangguniang Bayan and the same were included in the 2020 Annual Investment Plan/Program and Local Development Plan 2017-2022 of the Local Government Unit of Narvacan, Ilocos Sur;

**WHEREAS**, funds for the identified projects will be from local sources and national budgets particularly from the Local Government Support Fund-Other Financial Assistance to Local Government Units (LGSF-FA to LGUs) under the Department of Budget and Management (DBM);

**WHEREAS,** one of the requirements for the release of the LGSF-FA to LGUs Fund is a Sangguniang Bayan Resolution approving the acquisition of the said vehicles;
