## **RESOLUTION NO. 81**

A RESOLUTION AUTHORIZING THE HONORABLE LUIS "CHAVIT" C. SINGSON, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) TO HIRE THE SERVICES OF A DENTIST FOR NARVACAN, ILOCOS SUR

**WHEREAS**, the Municipal Administration and the Members of the Legislative Body recognize the necessity of providing the municipality adequate facilities and medical practitioners in line with its development agenda and its vision of a peaceful, orderly and healthy municipality;

**WHEREAS**, there is a crucial need to hire the services of a dentist who shall diagnose and treat dental issues and help patients develop better oral hygiene regimens;

**WHEREAS**, DR. GLENN ERIC DELA VEGA, DDM, shall be contracted as dentist of this municipality, exercising high skill and care in the provision of efficient dental services catering to the needs of thousands of clients from this municipality and nearby municipalities;

**WHEREAS**, DR. DELA VEGA shall have a scheduled every Wednesday and every other Friday visit or as the need arises and shall receive a monthly compensation of Three Thousand Pesos (Php 3,000.00) to commence upon the signing of the Memorandum of Agreement (MOA) which shall cover the period January 1, 2020 until December 31, 2020, renewable annually unless terminated by either of the party for cogent reason;

**NOW THEREFORE**, on motion duly seconded, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to authorize the HONORABLE LUIS "CHAVIT" C. SINGSON, Municipal Mayor, to enter into a Memorandum of Agreement (MOA) to hire the services of a dentist for Narvacan, Ilocos Sur;

**RESOLVED FURTHER** that upon urgent certification of the Municipal Mayor and motion unanimously approved suspending the rules on the 3-day readings of Resolutions, this Resolution shall be adopted immediately upon approval;
