RESOLUTION NO. 80

A RESOLUTION AUTHORIZING THE HONORABLE LUIS "CHAVIT" C. SINGSON, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE ILOCOS SUR DISTRICT HOSPITAL -NARVACAN (ISDH-N) FOR THE PURPOSE SPECIFIED HEREIN

WHEREAS, the Local Government Unit of Narvacan-Rural Health Unit is an accredited Basic Emergency Obstetric and Newborn Care (BEmONC) facility;

WHEREAS, the Ilocos Sur District Hospital-Narvacan (ISDH-N) is a duly accredited Level I hospital;

WHEREAS, LGU-Narvacan is affiliated with the ISDH-N for the referral of pregnant and obstetric management for complicated or high risk pregnancies;

WHEREAS, the ISDH-N shall admit, evaluate and process the referral cases to its facility;

WHEREAS, during referral of patients, the ISDH-N shall allow the use of their ambulance for conduction of maternal case purposes only;

WHEREAS, all services referred shall be payable to the ISDH-N by the patient;

NOW THEREFORE, on motion duly seconded, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to authorize the HONORABLE LUIS "CHAVIT" C. SINGSON, Municipal Mayor, to enter into a Memorandum of Agreement (MOA) with the Ilocos Sur District Hospital-Narvacan (ISDH-N) for the purpose specified herein;

RESOLVED FURTHER that upon urgent certification of the Municipal Mayor and motion unanimously approved suspending the rules on the 3-day readings of Resolutions, this Resolution shall be adopted immediately upon approval;

RESOLVED FINALLY that copies of this Resolution be forwarded to the Ilocos Sur District Hospital-Narvacan (ISDH-N) represented by RONALD REMEGIO T. TOBIAS, MD, Chief of Hospital, and to all persons and parties concerned for their information and appropriate actions.
