## **RESOLUTION NO. 77**

A RESOLUTION ADOPTING EXECUTIVE ORDER NO. 21-LCS, SERIES OF 2019 CREATING/REORGANIZING THE MUNICIPAL PEACE AND ORDER COUNCIL (MPOC) OF THE MUNICIPALITY OF NARVACAN, ILOCOS SUR

**WHEREAS,** Section 16 of Republic Act (RA) No. 7160, otherwise known as the Local Government Code of 1991 provides that local government units, within their respective territorial jurisdictions, shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhanced the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

**WHEREAS**, Section 116 of RA No. 7160 provides for the establishment in every municipality a Local Peace and Order Council pursuant to Executive Order No. 309, as amended, Series of 1988;

**WHEREAS**, the Municipal Peace and Order Council (MPOC) was created/ reorganized in the Local Government Unit of Narvacan, Ilocos Sur through Executive Order No. 21-LCS, Series of 2019;

**NOW THEREFORE**, on motion duly seconded, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to adopt Executive Order No. 21-LCS, S. 2019 Creating/Reorganizing the Municipal Peace and Order Council (MPOC) of the Municipality of Narvacan, Ilocos Sur;

**RESOLVED FURTHER,** that the Committee on Peace and Order of the Sangguniang Bayan of the municipality shall serve as the Consultative Body of said Council;

**RESOLVED FINALLY** that upon urgent certification of the Municipal Mayor and motion unanimously approved suspending the rules on the 3-day readings of Resolutions, this Resolution shall be adopted immediately upon approval, and that copies of this Resolution be forwarded to all persons and parties concerned for their information and appropriate actions.
