**A RESOLUTION REQUESTING THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE) TO GRANT/ALLOCATE FUNDS FOR THE "TULONG PANGHANAPBUHAY SA ATING DISADVANTAGED WORKERS" (TUPAD) OF THE MUNICIPALITY OF NARVACAN, ILOCOS SUR**

**WHEREAS**, the Department of Labor and Employment (DOLE) has always been a constant partner of the LGU when it comes to extending livelihood assistance to the local government of Narvacan, Ilocos Sur;

**WHEREAS**, said assistance has always been a great enhancement to the economic upliftment of the less fortunate and underprivileged constituents of the municipality;

**WHEREAS**, the Local Government Unit is willing and capable of providing the 20% equity of the total budget of the program which is being required by the DOLE;

**WHEREAS**, the Local Government of Narvacan authorizes the Honorable Luis "Chavit" C. Singson, Municipal Mayor to enter into a Memorandum of Agreement with the Department of Labor and Employment (DOLE) and the chosen beneficiaries, for the implementation of the said project;
