A RESOLUTION DESIGNATING THE HONORABLE LUIS 'CHAVIT' C. SINGSON, MUNICIPAL MAYOR OR ATTY. PABLO F. SANIDAD II, MUNICIPAL ADMINISTRATOR, AND MR. JOHN DAVID S. BARNACHEA, MUNICIPAL TREASURER-OIC AS NEW OFFICIAL SIGNATORIES OF THE PHIC-ACPS ACCOUNT AND ACPS-PF ACCOUNT

WHEREAS, new special accounts for the Philippine Health Insurance Corporation—Auto Credit Payment Scheme (PHIC-ACPS) and ACPS—PF (Professional Fee) were opened at the Land Bank of the Philippines, Narvacan, Ilocos Sur Branch;

WHEREAS, previously, the Honorable Luis "Chavit" C. Singson, Municipal Mayor or Atty. Pablo F. Sanidad II, Municipal Administrator, and Mrs. Gemma A. Cabanting were signatories of the said accounts;

WHEREAS, the Office of the Municipal Treasurer has new Officer-in-Charge in the person of **MR. JOHN DAVID S. BARNACHEA**. The Office of the Municipal Treasurer takes charge of the disbursement of all local government funds and such other funds the custody of which may be entrusted to the Office by law or other competent authority;

WHEREAS, the **Honorable Luis 'Chavit' C. Singson**, Municipal Mayor or Atty. Pablo F. Sanidad II, Municipal Administrator, and Mr. John David S. Barnachea, Municipal Treasurer—OIC shall now be the official signatories in all banking transactions concerning the PHIC-ACPS account and ACPS-PF account of the Local Government Unit of Narvacan, Ilocos Sur with the Land Bank of the Philippines – Narvacan Branch;

NOW THEREFORE, the Sangguniang Bayan of Narvacan, Ilocos Sur, in session assembled and on motion duly seconded, **RESOLVED AS IT IS HEREBY RESOLVED** to designate the Honorable Luis 'Chavit' C. Singson, Municipal Mayor or Atty. Pablo F. Sanidad II, Municipal Administrator, and Mr. John David S. Barnachea, Municipal Treasurer—OIC as official signatories of the PHIC-ACPS Account and ACPS PF Account;
