RESOLUTION REVOKING RESOLUTION NO. 58, SERIES OF RESOLUTION **ADOPTING** AND **APPROVING** AMENDED 2020 ANNUAL DEVELOPMENT PLAN OF MUNICIPALITY OF NARVACAN, ILOCOS SUR AS ENDORSED BY THE MUNICIPAL DEVELOPMENT COUNCIL AND RESOLUTION NO. 61, SERIES OF 2020 RESOLUTION APPROVING THE REALIGNMENT OF THE PROGRAMS, PROJECTS, ACTIVITIES UNDER THE 20% DEVELOPMENT FUND FOR CY 2020 FOR THE NARVACAN **COVID-19 RESPONSE** APPROPRIATING FUNDS THEREOF

**WHEREAS,** the Municipal Development Council (MDC), a multi-sectoral council mandated to identify and prioritize development projects, approved the 20% Annual Development Plan consisting of the list of priority projects and their corresponding appropriations which was submitted to the Sangguniang Bayan for adoption and approval;

**WHEREAS,** by virtue of a legislative action, Resolution No. 51, Series of 2020 Resolution Adopting the 2020 Annual Development Plan of the Municipality of Narvacan, Ilocos Sur as Proposed by the Municipal Development Council was immediately passed and approved by the Sangguniang Bayan of Narvacan, prescribing the projects subject for implementation under the 20% Annual Development Plan as endorsed by the Municipal Development Council for adoption;

**WHEREAS**, subsequently, the Sangguniang Bayan passed and approved Resolutions No. 58 and 61, substances of which are redundant and nomenclatures are not proper since Covid-19 is not under the development program of the Municipality;
