



EXCERPTS FROM THE MINUTES OF THE 15TH REGULAR SESSION OF THE SANGGUNIANG BAYAN OF NARVACAN, ILOCOS SUR HELD ON APRIL 27, 2020 AT THE MUNICIPAL SESSION HALL

**RESOLUTION NO. 66**

Series of 2020

**RESOLUTION URGING THE ILOCOS SUR ELECTRIC COOPERATIVE (ISECO) AND THE NARVACAN WATER DISTRICT (NWD) TO WAIVE ELECTRIC AND WATER CONSUMPTION FEES/CHARGES FOR THE ENTIRE PERIOD OF MARCH AND APRIL 2020 AS A FORM OF RELIEF TO ALL CONSUMERS, PUBLIC AND PRIVATE, AND ADHERE TO ANY AND ALL DIRECTIVES FROM THE INTER-AGENCY TASK FORCE (IATF)**

**WHEREAS**, Presidential Proclamation No. 922, Series of 2020, dated March 8, 2020 declared the entire country under a State of Public Health Emergency due to Covid-19;

**WHEREAS**, Presidential Proclamation No. 929, Series of 2020, dated March 16, 2020 placed the entire country under a State of Calamity for a period of six (6) months;

**WHEREAS**, on March 17, 2020, Pres. Rodrigo Roa Duterte placed the entire Luzon under Enhanced Community Quarantine in response to the growing pandemic of Covid- 19 in the country;

**WHEREAS**, the Enhanced Community Quarantine is an expanded version of community quarantine which mandates strict home confinement, suspension of transportation lines, regulation of provision for food and essential health services and heightened presence of uniformed personnel to enforce isolation procedures;

**WHEREAS**, the town of Narvacan is currently under the State of Enhanced Community Quarantine prohibiting residents from going out of their homes and suspending regular government and private transactions due to the Covid-19 pandemic;

**NOW THEREFORE**, on motion duly seconded, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to urge the Ilocos Sur Electric Cooperative (ISECO) and the Narvacan Water District to waive electric and water consumption fees/charges for the entire period of March and April 2020 as a form of relief to all consumers, public and private, and adhere to any and all directives from the Inter-Agency Task Force;

**RESOLVED FURTHER**, that copies of this Resolution be furnished to Ilocos Sur Electric Cooperative (ISECO) and to Narvacan Water District (NWD) and to all persons concerned, for their information and appropriate actions.
