

RESOLUTION NO. 60

Series of 2020

RESOLUTION APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 1-LCS FOR THE NARVACAN COVID-19 RESPONSE- PROGRAMS, PROJECTS, AND ACTIVITIES (PPAs)

WHEREAS, by virtue of Sec. 109 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Local Development Council (LDC) exercises the function of formulating/preparing development plans and investment programs, and shall be represented by the Executive Committee as shall be created pursuant to Sec. 111 of the Local Government Code, and shall act in its behalf when it is not in session in order to resolve matters requiring immediate action by the Council, in the best interest of public service;

WHEREAS, President Rodrigo Roa Duterte issued Presidential Proclamation No. 922, declaring a "State of Public Health Emergency" throughout the Philippines due to the Coronavirus Disease 2019 (COVID 19) and the Code Alert System for COVID-19 was raised to Code Red Sublevel Two (2) in accordance with the recommendation of the Department of Health (DOH) and the Inter-Agency Task Force for Emerging Infectious Disease (IATF). Further, Presidential Proclamation No. 929, S. 2020 was issued declaring a "State of Calamity" throughout the Philippines dueto COVID-19;


WHEREAS, both Proclamation enjoined all government agencies and LGUs to render full assistance to and cooperation with each other and mobilize the necessary resources to undertake crucial, urgent, and appropriate disaster response aid and measures in a timely manner to curtail and eliminate the threat of COVID-19;

WHEREAS, by reason of the current COVID-19 crisis affecting the entire nation, there is an urgent necessity to include the NARVACAN COVID-19 RESPONSE (Programs, Projects, and Activities) among the municipality's priority for the current year through this proposed Supplemental Investment Program (SIP) in order to rationalize the allocation of funds for various programs, projects and activities to curtail and eliminate the threat of COVID-19 in the Municipality of Narvacan;




