





RESOLUTION AUTHORIZING THE HONORABLE LUIS "CHAVIT" C. SINGSON, MUNICIPAL MAYOR OR ATTY. PABLO F. SANIDAD II, MUNICIPAL ADMINISTRATOR AND MR. JOHN DAVID S. BARNACHEA, MUNICIPAL TREASURER-OIC AS OFFICIAL SIGNATORIES OF ALL MUNICIPAL ACCOUNTS WITH THE LAND BANK OF THE PHILIPPINES

WHEREAS, the Municipality of Narvacan has existing accounts with the Land Bank of the Philippines – Narvacan Branch;

WHEREAS, RA 7160 otherwise known as The Local Government Code of 1991 orders the Members of the Sangguniang Bayan to authorize official signatories of all municipal accounts with the above-identified banking entity;

WHEREAS, the Municipality has a newly-installed Acting Municipal Treasurer, Mr. John David S. Barnachea, who is by law authorized as one of the official signatories of all municipal accounts;

WHEREAS, in order to update the aforementioned requirement, this resolution mandates the **Honorable Luis "Chavit" C. Singson**, Municipal Mayor and **Mr. John David S. Barnachea**, Municipal Treasurer-OIC as the official signatories of all financial transactions entered into by the Local Government Unit of Narvacan, Ilocos Sur with the Land Bank of the Philippines – Narvacan Branch;

WHEREAS, the urgency for the approval of this resolution is required upon the Sanggunian Bayan Council in as much as financial obligations, transactions and expenditures of the Municipal government need to be acted upon on a day to day basis;

WHEREAS, premises considered, the Sangguniang Bayan in session assembled and on motion duly seconded by the Body, **RESOLVED AS IT IS HEREBY RESOLVED** to authorize the **Honorable LUIS "CHAVIT" C. SINGSON**, Municipal Mayor or **Atty. PABLO F. SANIDAD II**, Municipal Administrator and **Mr. JOHN DAVID S. BARNACHEA**, Municipal Treasurer-OIC as official signatories of all municipal accounts with the Land Bank of the Philippines;
