



RESOLUTION NO. 46
Series of 2020

RESOLUTION ADOPTING RESOLUTION NO. R-674, SERIES OF 2000 PERTAINING TO THE APPLICATION OF LOCATIONAL CLEARANCE OF PIGGERY AND POULTRY, AS AMENDED, PASSED BY THE HOUSING AND LAND USE REGULATORY BOARD (HLURB)

WHEREAS, LGU Narvacan is swamped with problems on the illegal operation of piggery and poultry farms, be it small, medium or large scale, mostly of which are built in residential areas, in violation with existing rules and regulations;

WHEREAS, the growing demand for pork and chicken products has compromised the operation of piggery and poultry farms where increasing concerns on environmental pollution issues, especially those related to the disposal of waste and dead animals is now becoming unmanageable;

WHEREAS, social pressure for clean, odorless, sanitary and environment friendly piggery and poultry farms is the present outcry and clamor of Narvacaneans, petitioning for relocation in non-residential areas and conforming to the standards on pollution abatement as opposed to just receiving the financial benefits and income for piggery and poultry operators;


WHEREAS, with the premise of overriding the challenges on the illegal operation of piggery and poultry farms with a full on offensive, the Sangguniang Bayan of Narvacan, after weighing the issues, decree to pursue legal means to regulate the piggery and poultry business, whether it be backyard, small, medium or large scale pursuant to the directives of the HLURB;

WHEREAS, correspondingly, the problems can be averted even before the start of operation of piggery and poultry farms should there be strict compliance to the established environmental policies and guidelines embodied under RA No. R-674, Series of 2000, on the





application of locational clearance from the HLURB, thereby, nipping the problem in the bud at the outset, hence, preventing it from becoming ingrained;

NOW THEREFORE, on motion duly seconded and with the unanimous concurrence of the members of the Sangguniang Bayan, **RESOLVE** as it is hereby **RESOLVED**, the Adoption of Resolution No. R-674, Series of 2000, as amended, pertaining to the application of Locational Clearance of piggery and poultry passed by the Housing And Land Use Regulatory Board (HLURB) to wit:

- a) The issuance of the **locational clearance** by the HLURB or city/municipality concerned shall cover the **location or siting** of all piggery and poultry projects as defined hereof, and prescribe minimum standards for development, public health and welfare and environmental safeguards;
- b) The rules and regulations shall apply to all applications for locational clearance of new development and or expansion of existing piggery or poultry with the HLURB or the city/municipality concerned.
