





RESOLUTION EARNESTLY REQUESTING THE PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO), MANDALUYONG CITY, MANILA, REPRESENTED BY RET. P/CSUPT ANSELMO SIMEON P. PINILI, CHAIRMAN, TO DONATE ONE (1) UNIT BRAND NEW FIRE TRUCK FOR THE OFFICIAL USE OF THE MUNICIPALITY OF NARVACAN, ILOCOS SUR

WHEREAS, the Municipal Administration, in its commitment to pursue a vision of a peaceful and progressive community, is enacting measures to ensure the safety and welfare of the people;

WHEREAS, one of these measures is to promote efficient fire prevention service to the people of Narvacan by acquiring a new fire truck which shall be used in assisting, transporting, responding and providing fire fighters access to fires during the occurrence of conflagration;

WHEREAS, the forty (40) year-old fire truck being used by the Municipality is not capable to meet the demands of ensuring fire prevention/protection and rescue operations in cases of emergencies;

WHEREAS, it is paramount for the LGU to acquire one (1) brand new fire truck that shall gear up our plans of modernizing our fire prevention campaigns and rescue operations for our fast-growing community;

WHEREAS, the new fire truck shall competently contribute in the fast and effective response to fire and other emergencies not only in the locality but in the neighboring towns as well;

WHEREAS, this Local Government Unit could not provide for such necessity and is now seeking the help of the PCSO to provide the same;

NOW THEREFORE, the Sangguniang Bayan of Narvacan, Ilocos Sur, in session duly assembled and on motion duly seconded, **RESOLVED AS IT IS HEREBY RESOLVED** to request the Philippine Charity Sweepstakes Office (PCSO), Mandaluyong City, Manila, represented by **RET. P/CSUPT ANSELMO SIMEON P. PINILI**, Chairman, to donate one (1) unit brand new fire truck for the official use of the Municipality of Narvacan, Ilocos Sur;
