RESOLUTION AUTHORIZING THE HONORABLE LUIS "CHAVIT" C. SINGSON, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) REGIONAL OFFICE I, REPRESENTED BY CARLITO M. TUBALLA, REGIONAL DIRECTOR, FOR THE PREPARATION OF FOREST LAND USE PLAN (FLUP) OF NARVACAN, ILOCOS SUR

WHEREAS, the Department of Environment and Natural Resources (DENR) is the lead national government agency responsible for the sustainable management of the country's environment and natural resources and exercises supervision and control over forests and forestlands including the issuance of tenure instruments in forestlands;

WHEREAS, Section 3 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 directs the local government units to share with the national government the responsibility in the management of natural resources and maintenance of ecological balance within their territorial jurisdiction;

WHEREAS, the DENR and the Department of Interior and Local Government (DILG) jointly issued Memorandum Circular No. 98-01 dated July 16, 1998 specifying the manual of procedure for DENR-DILG-LGU partnership on devolved and other forest management functions;

WHEREAS, the DENR-DILG-LGU Joint Memorandum Circular No. 98-01 mandates the DENR and LGU together with other agencies to undertake forest land use planning to determine the optimum and balance use of natural resources to support local, regional, and national growth and development;

WHEREAS, the DENR and DILG further issued Joint Memorandum Circular No. 2003-01 dated May 19, 2003 to accelerate the collaboration, coordination and institutionalization of the working relationship among these agencies on the devolved and other forest management functions;
