RESOLUTION EARNESTLY REQUESTING THE HONORABLE WILLIAM DAR, SECRETARY, DEPARTMENT OF AGRICULTURE (DA) TO PROVIDE FINANCIAL ASSISTANCE IN THE AMOUNT OF TWELVE MILLION FIVE HUNDRED THOUSAND PESOS (P 12.5 M) FOR DEVELOPMENT PROJECTS OF THIS MUNICIPALITY

WHEREAS, the Department of Agriculture (DA), a government agency responsible for the promotion of agricultural development by providing framework, public investments, and essential support services;
