**RESOLUTION AUTHORIZING THE HONORABLE LUIS "CHAVIT" C. SINGSON, MUNICIPAL MAYOR, AND/OR ATTY. PABLO F. SANIDAD II, MUNICIPAL ADMINISTRATOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH ALL ACCESS AUDIO AND LIGHTS SPECIALIST FOR THE PROVISION OF SOUND, LIGHTS, AND EFFECTS SYSTEM DURING THE NARVACAN BEACH MOVIE NIGHT ON FEBRUARY 14, 2020 AT BULANOS BEACH, NARVACAN, ILOCOS SUR**
