RESOLUTION DESIGNATING THE HONORABLE EDNA C. SANIDAD, CHAIR, COMMITTEE ON APPROPRIATIONS, BUDGET AND FINANCE, WAYS AND MEANS, HONORABLE CHARITO C. VILORIA, CHAIR, COMMITTEE ON PUBLIC ENTERPRISE, TRADE AND INDUSTRY, AND HONORABLE BERNADETTE C. LIM, CHAIR, COMMITTEE ON RULES, PRIVILEGES, GOOD GOVERNANCE, PUBLIC ETHICS, ORDINANCES AND LEGAL MATTERS AS MEMBERS OF THE MUNICIPAL REGULATORY REFORM TEAM

WHEREAS, Section 5 of Republic Act No. 11032, otherwise known as the **Ease of Doing Business and Efficient Government Service Delivery Act of 2018** provides that "all offices and agencies which provide government services are hereby mandated to regularly undertake cost compliance analysis, time and motion studies, undergo evaluation and improvement of their transaction systems and procedures and reengineer the same if deemed necessary to reduce bureaucratic red tape and processing time";

WHEREAS, DILG MC 2018-214 entitled "Reengineering of LGU Systems and Procedures on Ease Of Doing Business and Efficient Government Service Delivery Act of 2018" enjoins Local Government Units to initiate reengineering of its operations and procedures in support to the implementation of the abovementioned Act and in view of the Philippine Development Plan 2017-2022 that ensures People-Centered, Clean, and Efficient Governance through seamless service delivery;

WHEREAS, DILG-ARTA JMC 2019-01 dated December 10, 2019 sets "Guidelines on the Regulatory Reform for Local Government Units Pursuant to the Ease of Doing Business and Efficient Government Service Delivery (EODB-EGSD) Act of 2018" to assist LGUs in complying with the standards of the Act and to ensure good regulatory practices in their policy making process;

WHEREAS, the same Joint Memorandum Circular mandates the creation and designation of the Regulatory Reform Team in order to facilitate the activities of the Regulatory Reform;

NOW THEREFORE, in session duly assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to designate the HONORABLE EDNA C. SANIDAD, Chair, Committee on Appropriations, Budget and Finance, Ways and Means, HONORABLE CHARITO C. VILORIA, Chair, Committee on Public Enterprise, Trade and Industry, and HONORABLE BERNADETTE C. LIM, Chair, Committee on Rules, Privileges, Good Governance, Public Ethics, Ordinances and Legal Matters as members of the Municipal Regulatory Reform Team;
