RESOLUTION CONCURRING IN THE GRANT OF SPECIAL COCKPIT OPERATOR'S PERMIT (SCOP) TO MR. LEONARDO B. BAPTISTA AND PROVIDING FOR THE CONDITIONS THEREOF

WHEREAS, the Office of the Municipal Mayor of Narvacan, Ilocos Sur forwarded to the Sangguniang Bayan a letter request received on January 28, 2020, from one Mr. LEONARDO B. BAPTISTA, requesting for the issuance of a Cockpit Operator's Permit (COP) in the Municipality of Narvacan, particularly at Barangay Bulanos;

WHEREAS, P.D. 1802-A provides that a Cockpit Operator's Permit (COP) can be issued provided it is with the concurrence of the Sangguniang Bayan;

WHEREAS, the Sangguniang Bayan of Narvacan has no objection to the issuance of a Special Cockpit Operator's Permit (SCOP) to the applicant Mr. LEONARDO B. BAPTISTA, on certain terms and conditions.

NOW THEREFORE, on motion duly seconded and with the unanimous concurrence of the members of the Sangguniang Bayan, **RESOLVE** as it is hereby **RESOLVED** that the Sannguniang Bayan of Narvacan has NO OBJECTION and hereby CONCURS in the issuance of a Special Cockpit Operator's Permit (SCOP) to Mr. LEONARDO B. BAPTISTA under the following terms and condition:

1. Considering that the Sangguniang Bayan is currently in the process of amending/repealing the Revenue Code, more particularly, the provisions regulating the operation of cockpits and is formulating the enactment of a more realistic and updated Ordinance, specifically "Regulating the Establishment, Operation, Maintenance, etc. of Cockpits in Narvacan", and without prejudice to the final passage and approval of the same, the SCOP granted to Mr. LEONARDO B. BAPTISTA shall only be for the limited period of **six (6) months** commencing on the date the said SCOP is issued unless sooner terminated for cause, or in the meantime the proposed new Ordinance shall have been enacted, in which case a new COP shall have to be obtained pursuant to the provisions of said Ordinance, although the PREVIOUS payment of all taxes and fees shall be credited in favor of Mr. LEONARDO B. BAPTISTA;

- 2. That all documentary requirements for the establishment, maintenance and operation of a cockpit shall be obtained and complied with by Mr. Baptista and he shall pay an annual tax in the amount of FIFTY THOUSAND PESOS (Php 50,000.00); and provided further, that for each individual cockfight held in the said cockpit, whether the same ends in a draw or otherwise, a fee of ONE HUNDRED FIFTY PESOS (Php 150.00) shall also be collected and paid to the municipality;
- 3. That all pertinent provision of law, especially, but not limited to P.D. 440, the Cockfighting Law of 1974, as amended, and the rules and regulation promulgated by the Philippine Game Fowl Commission and such other government agencies that may have jurisdiction over the maintenance and operation of cockpits shall be faithfully obeyed and complied with;
- 4. That all other local municipal ordinances, orders, issuances, rules and regulations, which are inconsistent with the above terms and conditions are in the meantime suspended until the enactment and approval of the new Ordinance;
- 5. That all structures erected in the site shall be subject to the provisions of the Building Code and relevant rules and regulations and duly approved by the Municipal Engineer's Office withall adequate consideration for the demands of security and sanitation;
- 6. That all employees of the operator, such as, but not limited to the referee, gaffer, bet taker, promoter, etc. shall secure and pay permit fees to the municipality, at the uniform rate of FIVE HUNDRED PESOS (Php 500.00) annually.
