WHEREAS, the Department of Public Works and Highways (DPWH) is the executive department of the Philippine government solely vested with the mandate to be the state's engineering and construction arm;

WHEREAS, the Department of Public Works and Highways is mandated to provide technical services for the planning, design, construction, maintenance or operation of infrastructure facilities;

WHEREAS, the DPWH is mandated to assist other agencies, including the local governments, in determining the most suitable entity to undertake the actual construction of public works projects;

WHEREAS, the Municipal Administration identified priority projects to sustain its development efforts thereby strengthening the economy of the municipality;

WHEREAS, in pursuing the right avenues for development, the Municipal Administration, included in these priorities different infrastructure projects such as:
