A RESOLUTION ENDORSING THE LIST OF PROGRAMS AND PROJECTS TO BE IMPLEMENTED OUT OF THE REMAINING SHARES OF THE MUNICIPALITY OF NARVACAN, ILOCOS SUR FROM THE FY 2015 COLLECTION OF EXCISE TAXES ON LOCALLY MANUFACTURED VIRGINIA-TYPE CIGARETTESIN PURSUANT TO, REPUBLIC ACT NO. 7171 UNDER THE DEPARTMENT OF BUDGET AND MANAGEMENT LOCAL BUDGET MEMORANDUM NO. 76-A AMOUNTING TO SIX MILLION NINE HUNDRED FIFTY SEVEN THOUSAND EIGHT HUNDRED AND FORTY TWO PESOS (PHP 6,957,842.00)

WHEREAS, by virtue of Republic Act No. 7171, an "Act to Promote the Development of the Farmers in the Virginia Tobacco-Producing Provinces" declares a State policy to extend special support to the farmers of the Virginia Tobacco-Producing Provinces inasmuch as theses farmers are the nucleus of the Virginia Tobacco industry which generates a sizeable income, in terms of excise taxes from locally manufactured Virginia-Type Cigarettes and customs duties on imported blending tobacco, for the National Government;

WHEREAS, the special support to the Virginia Tobacco-Producing Provinces shall be utilized to advance the self-reliance of the tobacco farmers through:
(a) Cooperative Projects that will enhance better quality of products, increase productivity, guarantee the market and as a whole increase farmers' income;
(b) Livelihood Projects particularly the development of alternative farming system to enhance farmers' income; (c) Agro-Industrial Projects that will enable tobacco farmers in the Virginia Tobacco-Producing Provinces to be involved in the management and subsequent ownership of these projects such as post-harvest and secondary processing like cigarette manufacturing and by-product utilization; and (d) Infrastructure Projects such as farm-to-market roads;

WHEREAS, the programs, projects, and activities to be implemented are consistent with the guidelines issued by the Department of Budget and Management, Local Budget Memorandum No. 76, dated October 6, 2017;

WHEREAS, the programs, projects, and activities to be implemented are included in the approved Annual Investment Program (AIP) of the Municipality of Narvacan, Ilocos Sur, which are as follows:
