Series of 2020**

RESOLUTION AUTHORIZING THE HONORABLE LUIS "CHAVIT" C. SINGSON, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH ILOCOS SUR DISTRICT HOSPITAL-NARVACAN, THE LATTER AS A REFERRAL FACILITY FOR THE PROVISION OF NEWBORN HEARING SCREENING SERVICE TO NEWBORN BABIES BORN IN NARVACAN RURAL HEALTH UNIT-BIRTHING FACILITY

WHEREAS, the Local Government Unit of Narvacan, Ilocos Sur has a birthing home registered as Narvacan Rural Health Unit-Birthing Facility which provides maternity care to pregnant women such as prenatal, midwife-assisted delivery and postnatal care to mothers, and Newborn Care and Newborn Screening Test to newborn babies;

WHEREAS, Ilocos Sur District Hospital-Narvacan is a registered and licensed Newborn Hearing Screening Center equipped with a newborn hearing loss screening and audio logic diagnostic evaluation laboratory that complies with the standards established by the National Institute for Health and administers the required laboratory tests and implements recall and follow-up programs for infants with hearing loss;

WHEREAS, the Local Government Unit of Narvacan, Ilocos Sur due to financial constraints and professional requirements, is unable to provide Newborn Hearing Screening Service as a requirement for Philhealth accreditation;

WHEREAS, the Local Government Unit of Narvacan, Ilocos Sur signified its intention to forge partnership with Ilocos Sur District Hospital-Narvacan as the Referral Facility to facilitate the hearing screening test of newborn babies born in Narvacan Rural Health Unit-Birthing Facility;






