RESOLUTION ADOPTING EXECUTIVE ORDER NO. 24-LCS, SERIES OF 2019 CREATING/REORGANIZING THE LOCAL HEALTH BOARD OF THE MUNICIPALITY OF NARVACAN, ILOCOS SUR

WHEREAS, the 1987 Philippine Constitution provides that the State shall adopt an integrated and comprehensive approach to health development which shall endeavour to make essential goods, health and other social services available to all the people;

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that the Local Government Units shall ensure, support, and promote health and safety among its residents and mandates the creation of a Local Health Board in every province, city, or municipality;

WHEREAS, through Executive Order No. 24-LCS, Series of 2019, the Local Health Board of the Municipality of Narvacan, Ilocos Sur was created/reorganized;

WHEREAS, the Local Health Board, among its other duties and functions, shall serve as an advisory committee to the Sanggunian concerned on health matters such as, but not limited to, the necessity for, and application of local appropriations for public health purposes;

NOW THEREFORE, on motion duly seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to adopt Executive Order No. 24-LCS, Series of 2019 Creating/Reorganizing the Local Health Board of the Municipality of Narvacan, Ilocos Sur;
