

RESOLUTION NO. 10
Series of 2020

RESOLUTION EXTENDING THE DEADLINE FOR THE RENEWAL OF BUSINESS TAXES, MAYOR'S PERMIT FEES AND OTHER RELATED CHARGES FROM JANUARY 20, 2020 TO JANUARY 31, 2020

WHEREAS, the renewal of business licences and payment of Mayor's Permit fees and other related charges commence at the beginning of each year and end on the 20th of January;

WHEREAS, records show that most of the municipality's business establishments/operators have not yet renewed their licences and Mayor's Permit for the current year;

WHEREAS, Section 167 of the Local Government Code of 1991 provides:

"SECTION 167. Time of Payment. - Unless otherwise provided in this Code, all local taxes, fees and charges shall be paid within the first twenty (20) days of January or of each subsequent quarter, as the case may be. The sanggunian concerned may, for a justifiable reason or cause, extend the time for payment of such taxes, fees, or charges without surcharges or penalties, but only for a period not exceeding six (6) months."

WHEREAS, it is for the interest of the business proprietors who have yet to renew their business permits to extend the deadline of the payment of taxes and business permit renewal to avoid surcharges or penalties;

NOW THEREFORE, on motion duly seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to extend the deadline for the renewal of business taxes, Mayor's Permit fees and other related charges from January 20, 2020 to January 31, 2020;
