

RESOLUTION AUTHORIZING THE HONORABLE LUIS "CHAVIT" C. SINGSON, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) TO HIRE THE SERVICES OF A CLINICAL PATHOLOGIST FOR THE NARVACAN MUNICIPAL HEALTH OFFICE CLINICAL LABORATORY

WHEREAS, various laboratory services are rendered by the Municipal Health Office of Narvacan, Ilocos Sur and is now in the process of applying for a license to operate a secondary clinical laboratory;

WHEREAS, there is a need to hire the services of a Clinical Pathologist in support to the creation of the Narvacan Municipal Health Office Clinical Laboratory;

NOW THEREFORE, the Sangguniang Bayan of Narvacan, Ilocos Sur in a regular session assembled, **RESOLVED AS IT IS HEREBY RESOLVED** to authorize the **Honorable Luis "Chavit" C. Singson**, Municipal Mayor, to enter into a Memorandum of Agreement (MOA) to hire the services of a Clinical Pathologist for the Narvacan Municipal Health Office Clinical Laboratory;

and



WITNESSETH


1. That the Second Party has signified her intention, to which the First Party has accepted to provide the services needed by the latter;
2. That the Second Party hereby possesses the necessary education, has completed training in an accredited institution, experience and skills as required by the First Party;
3. That the Second Party shall receive a monthly compensation of P 5,000.00 to commence upon signing of the agreement;
4. That the Second Party shall have a scheduled monthly visit or as the need arises;
5. That the Second Party shall ensure that all requirements for licensure and accreditation by the Department of Health (DOH) are met by the laboratory;
6. This Memorandum of Agreement shall cover the period January 1, 2020 until December 31, 2020 renewed yearly unless be terminated by the either party for cogent reason by giving 30 days written notice to that effect.


