AN ORDINANCE CREATING SEVEN (7) POSITIONS AND ONE (1) OFFICE IN THE LOCAL GOVERNMENT UNIT OF NARVACAN ILOCOS SUR

BE IT ENACTED by the Sangguniang Bayan of Narvacan, Ilocos Sur in session assembled that:

SECTION 1. It is the policy of the Municipality to determine the offices, positions, and salaries for the proper conduct of programs, projects, services and activities of the Municipal Government;

SECTION 2. For the judicious improvement of services to the people, the new seven (7) positions and one (1) office be created:

- (a) Market Supervisor V – SG 24, Item No. 19 under the Office of the Market Enterprise and Management with annual salary of P 279,399.00 effective January 1, 2009;
- (b) Administrative Aide IV – SG 4, Item No. 23 under the Office of the Market Enterprise and Management with annual salary of P 87,505.00 effective January 1, 2009;
- (c) Electrical Inspector II – SG 8, Item No. 25 under the Office of the Market Enterprise and Management with annual salary of P 116,857.00 effective January 1, 2009;
- (d) Security Agent I – SG 8, Item No. 26 under the Office of the Market Enterprise and Management with annual salary of P 116,857.00 effective January 1, 2009;
- (e) Agriculturist II – SG 15, Item No. 76 under the Office of the Municipal Agriculturist with annual salary of P 178,451.00 effective January 1, 2009;
- (f) Office of the Business Permit and Licensing Office effective January 1, 2009;
- (g) Licensing Officer V – SG 24, Item No. 27 under the Office of the BPLO with annual salary of P 279,399.00 effective January 1, 2009;
- (h) Licensing Officer IV – SG 22, Item No. 28 under the Office of the BPLO with annual salary of P 258,302.00 effective January 1, 2009.


SECTION 3. This Ordinance shall take effect on the date abovementioned.
