AN ORDINANCE AMENDING SECTION 5-B OF ORDINANCE NO. 98-14, SERIES OF 2001 ENTITLED AN ORDINANCE PROHIBITING SCHOOL PUPILS AND STUDENTS FROM LOITERING/PLAYING IN VIDEO BARS/BILLIARD HALLS DURING SCHOOL DAYS

WHEREAS, on January 30, 2001, the Municipality of Narvacan enacted Ordinance No. 98-14, Series of 2001 entitled An Ordinance Prohibiting School Pupils And Students From Loitering/Playing In Video Bars/Billiard Halls During School Days;

WHEREAS, Section 5-B of Ordinance No. 98-14, Series of 2001 provides for the penalty for the operators/owners of Video Bars/Billiard Halls violating the said Ordinance;

WHEREAS, the Municipal Government of Narvacan deems it very necessary to effect an increase in the fines so as to ensure strict observance of the Ordinance;

NOW THEREFORE, BE IT RESOLVED by the Sangguniang Bayan duly assembled to enact this amending ordinance:

SECTION 1. Section 5-B of Ordinance No. 98-14, Series of 2001 otherwise known as An Ordinance Prohibiting School Pupils And Students From Loitering/Playing In Video Bars/Billiard Halls During School Days is hereby amended as follows:


Section 5-B. Operators/owners of Video Bars/Billiard Halls violating this Ordinance shall be meted fines as specified below:

First Offense.....	Warning
Second Offense.....	P 1,000.00
Third Offense.....	P 2,000.00
Succeeding Offense.....	Closure of the video bar/billiard hall


SECTION 2. Implementation. The Local PNP is hereby authorized to implement this Ordinance in accordance with existing laws and regulations.

SECTION 3. Effectivity. This Ordinance shall take effect 30 days after its approval.






