**ORDINANCE NO. 37**

**AN ORDINANCE REINFORCING THE GUIDELINES FOR THE ADOPTION OF THE RECOMMENDATIONS OF THE PROVINCIAL GOVERNMENT OF ILOCOS SUR AND IMPLEMENTATION OF STRICT LOCALIZED GUIDELINES IN THE MUNICIPALITY OF NARVACAN, ILOCOS SUR FOR THE PERIOD AUGUST 7 – 20, 2020**

**WHEREAS**, pursuant to the latest IATF Resolution, the Province of Ilocos Sur is placed under Modified General Community Quarantine (MGCQ) from August 4, 2020 to August 15, 2020;

**WHEREAS**, Ilocos Sur has a total of fifty (50) Covid-19 confirmed cases but as of August 10, 2020 it has just recorded thirty five (35) new recoveries which brings a total number of active confirmed cases down to eight (8);

**WHEREAS**, most of the recorded cases in the Province came from Vigan City, Candon City, Caoayan and Magsingal. The Municipality of Narvacan has recorded three (3) positive cases;

**WHEREAS**, the abrupt increase in positive cases and the confirmation of local transmission alarmed the medical team of Ilocos Sur prompting it to recommend the re-classification of the status of Vigan City, Candon City, Caoayan and Magsingal to Modified Enhanced Community Quarantine (MECQ) to have more stringent quarantine restrictions;

**WHEREAS**, by reason of the surge of Covid-19 cases in the Ilocos Sur, the Municipal Government of Narvacan imposes guidelines for the adoption of the recommendations of the Provincial Government of Ilocos Sur and implementation of strict localized guidelines in the Municipality for the period August 7-20, 2020;

**NOW THEREFORE, BE IT ORDAINED** by the Sangguniang Bayan of Narvacan, Ilocos Sur in session duly assembled that:

**SECTION 1.** The guidelines set forth by the Office of the Municipal Mayor for the adoption of the recommendations of the provincial government of Ilocos Sur and implementation of strict localized guidelines shall apply to the Municipality of Narvacan and shall be effective for

the period August 10, 2020 to August 20, 2020, or until such time that the Modified General Community Quarantine (MGCQ) in the Province of Ilocos Sur is lifted or modified by the Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF-EID).

**SECTION 2.** Any person who shall violate any of the guidelines shall be penalized:

- First Offense - P 1,000.00
- Second Offense - P 2,000.00
- Third and subsequent offenses - P 2,500.00 or imprisonment of one month or both at the discretion of the Court

**SECTION 3.** Due to the present health emergency and the situation of the entire country, and upon motion duly approved suspending the rule of the 3-day reading for the passage of an edict, this Ordinance shall take effect immediately upon its approval.

Let copies of this Ordinance be posted at conspicuous places in the municipal hall.
