**AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 11, SERIES OF 2020 INVOLVING AN AMOUNT OF SIX HUNDRED TWENTY THOUSAND PESOS ( P 620,000.00)**

**Section 6. Effectivity.** The provisions of this Ordinance shall take effect immediately upon approval.






