RESOLUTION EXPRESSING SUPPORT TO HOUSE BILL 8918 FILED IN
CONGRESS BY REP. ERIC D. SINGSON

WHEREAS, the Hon. Eric D. Singson of the second district of Ilocos Sur has filed House Bill 8918 entitled "AN ACT CONVERTING THE MUNICIPALITY OF CANDON INTO A COMPONENT CITY TO BE KNOWN AS THE CITY OF CANDON."

WHEREAS, the House of Representatives has now approved House Bill 8918 during its final and third reading and that it is now in the Senate of the Philippines for conduct of a Public Hearing;

WHEREAS, the importance and need of having a qualified municipality like Candon to become a city and represent/lead the whole province of Ilocos Sur towards much awaited progress, development and region-wide, as well as nationwide, recognition has long been overdue;

WHEREAS, Candon has met all the necessary requirements for the cityhood, like; land area and yearly income, as well as popular support among their townspeople and their neighboring brother Ilocanos.

NOW THEREFORE, the Sangguniang Bayan of the Municipality of Narvacan, Ilocos Sur represented herein by Vice Mayor Charito S. Zaragoza, in a meeting duly assembled,

RESOLVED, AS IT IS HEREBY RESOLVED to extend support to House Bill 8918 seeking to convert the Municipality of Candon, Ilocos Sur into a component city;

RESOLVED FURTHER that copies of the resolutuion be forwarded to the Senate of the Philippines through the HON. SENATOR VICENTE C. SOTTO III, Chairman, Senate Committee on Local Government for their information and guidance.
