RESOLUTION REQUESTING THE PHILIPPINE CHARITY SWEEPSTAKES OFFICE TO TRANSFER MANAGEMENT AND OWNERSHIP OF THE PCSO-ISSUED AMBULANCE FROM MRS. JULIET VILORIA TO THE LOCAL GOVERNMENT UNIT OF NARVACAN, ILOCOS SUR

WHEREAS, the delivery of basic health services to the people is a devolved function of the Local Government Unit pursuant to RA 7160 otherwise known as the Local Government Code of 1991;

WHEREAS, an ambulance issued by the Philippine Charity Sweepstakes Office has been lodged to a certain Mrs. Juliet Viloría of Narvacan, Ilocos Sur and is reportedly the chairman of BILEG Ti Narvacan Cooperative;

WHEREAS, the ambulance is being kept for political purposes because the disposition of its use is dependent on her decision, but said ambulance is apparently being used to service her political clients;

WHEREAS, the members of the Municipal Council took cognizant of the possibility that under such circumstance, the ambulance does not serve its mandated purpose of providing convenient vehicle for patients in emergency cases regardless of their political affiliations;


WHEREAS, the subject ambulance is better kept and maintained if it is to be managed by the Local Government Unit of Narvacan, Ilocos Sur as it has the capability to operate said vehicle, notwithstanding that it will serve a broader base of clients coming from all barangays of the municipality.

NOW THEREFORE, on motion of Kgd. Margarito Tejada, duly seconded by the Body, BE IT RESOLVED AS IT IS HEREBY RESOLVED to request the Philippine Charity Sweepstakes Office to transfer the management and ownership of the PCSO-issued ambulance from Mrs. Juliet Viloría to the Local Government Unit of Narvacan, Ilocos Sur.

RESOLVED FINALLY that copies of this Resolution be forwarded to the Hon. Chairman of the PCSO for her information and appropriate action.
