RESOLUTION REQUESTING THE **HON. SIMEON DATUMANONG, SECRETARY OF THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS** FOR HIS ASSISTANCE IN ALLOCATING FUNDS FOR THE MUNICIPALITY OF NARVACAN, ILOCOS SUR TO FUND RELIEF EFFORTS OF THE LOCAL GOVERNMENT FOR THE INFRASTRUCTURE SECTOR AFFECTED BY TYPHOON FERIA IN THE MUNICIPALITY

WHEREAS, the Municipality of Narvacan in Ilocos Sur was hardest hit by typhoon FERIA that brought untold damages to agricultural crops, livestock, river controls and seawalls, secondary bridges, barangays roads, homes and other personal properties of affected families in all of the 34 barangays of Narvacan, Ilocos Sur;

WHEREAS, relief efforts have been very minimal owing to the need for a more substantial amount of money to fund the over-all recovery, restructuring and relief operations of the Local Government Unity of Narvacan, Ilocos Sur;

WHEREAS, typhoon FERIA left the people and the local government of Narvacan, Ilocos Sur, as in other towns of Ilocos Sur, financially-draining aftermath considering the numerous infrastructures devastated by it;

WHEREAS, the members of the Municipal Council and the Municipal Administration are sourcing funds to augment relief activities initiated by the Local Government of Narvacan, Ilocos Sur;

NOW THEREFORE, on motion of **Kgd. Oscar Potencion**, duly seconded by the Body, BE IT RESOLVED AS IT IS HEREBY RESOLVED to request the **Hon. Simeon Datumanong, Secretary of the Department of Public Works and Highways**, for his assistance in allocating funds for the Municipality of Narvacan, Ilocos Sur to fund relief efforts of the Local Government for the infrastructure sector affected by typhoon FERIA in the Municipality.

RESOLVED FINALLY that a copy of this Resolution be forwarded to the **Hon. Simeon Datumanong, Secretary of the Department of Public Works and Highways** for his information and approval.
